It's that time again, and we are pleased to offer another year of quality education at Queen of Angels Catholic School. We ask that you carefully read the instructions for completing the attached form. Please fill in the information on the attached Re-registration and Tuition Payment Preference form and return it with the non-refundable re-registration fee of \$200 **per child** to the school. The school will be offering 2 more options for FACTS payment withdrawal dates so please be sure to circle your preference on the attached form.

We also want to remind you of several school policies (page 10 in the Queen of Angels Catholic School Handbook). We are bringing these to your attention because we want to make sure that you clearly understand these policies will be implemented in the upcoming re-registration process.

- The re-registration period will be **Friday, January 29 through noon on Friday, February 26**. A seat will be reserved for the 2010-11 academic year for your currently enrolled student(s) if you re-register by the February 26 deadline.


Due to the large number of applicants for all grades, we must make an informed decision about current students as well as new applicants by February 26th. If you do not re-register within the required timeframe, your child's application will go into the pool with all new applicants and thus your child may lose his/her seat for the new school year.




- Re-registration will be an option only for families whose financial commitment to the school is current.
